

- This is the 5<sup>th</sup> week in a row that the adjusted case rate has been between 9 and 11 new COVID-19 cases per 100,000 population.



Note: Due to delays in specimen processing, totals for the past two weeks may be incomplete.







#### COUNTY RISK LEVEL




## COMMUNITY MONITORING – EMERGENCY CASES **COVID-19 LIKE ILLNESS**
